**ORDER**

As per the Government Order read as 2<sup>nd</sup> paper above, sanction was accorded for the implementation of the pilot project of She-Taxi as a joint venture of the Gender Parks and Kerala State Women's Development Corporation as per the project proposal submitted by the Special Officer, Gender Parks and duly approved by Kerala State Women's Development Corporation. As per the project proposal submitted by the Special Officer, the total loan amount required from Kerala State Women's Development Corporation was Rs.500 lakhs. The pilot project was for the implementation of 25 She-Taxi's. Now, as per his letter read as 3<sup>rd</sup> paper above, the Special Officer, Gender Parks has requested to extend the number of loans to She-Taxi beneficiaries from 25 to 75 with the same terms and conditions in the proposal already submitted by him. The Managing Director, Kerala State Women's Development Corporation, as per his letter read as 4<sup>th</sup> paper above, has also agreed to the proposal and reported that there will be no extra financial commitment to KSWDC in extending the number of loans.

(2) Government have examined the matter in detail and are pleased to accord sanction in extending the number of loans to She-Taxi beneficiaries from 25 to 75 numbers limiting the total amount of loans to Rs.500 lakhs (five hundred lakhs only) subject to the same terms and conditions mentioned in the Government Order 2<sup>nd</sup> cited and in the proposal read as 1<sup>st</sup> paper above.
